## V. BUSINESS OPERATIONS

This report was given by Rick Goshorn, Director of Business Operations:

## A. Budget Review

State appropriations increased from \$5.85M to \$5.97M. The state employee increases are three percent starting in April and four percent in July. The county's revenue to the college has increased by 12% which will help with the compensation funding for college employees.

The state legislature is looking to add another 2% to the ERB.

The state legislature has set a \$15 minimum wage for state employees.

This will cost UNM Valencia \$121,000 in wages and \$4,500 in extra benefits.

Enrollment is stable, which is an improvement from last year. Tuition will stay the same.

Reserves were budgeted to fund staffing the WFTCI, however internal shifts in staffing helped fund those costs.

Insurance will increase-healthcare will have components that will increase that the branch will have to fund, 2.7%-not a large impact to the budget.

In 2023, additional funding from the Dept of Education will be given to UNM-Valencia to spend by March 2023 for the students.

Grants are a major funding source for the Valencia Campus.

Auxiliary enterprises (bookstore, café) are close to deficit. Changes will have to be made if they can't make revenue-a new way of management of these enterprises will need to be figured out.
