Course description: An introduction to terminology used in health careers. It will provide a basic knowledge of prefixes, suffixes, and root words used in describing anatomical parts of the human body as well as general terms relating to disease processes.

Textbook: *Medical Terminology: A Living Language*, 6th edition (Pearson) **and** *MyMedicalTerminologyLab* (online access code comes with textbook)

Student learning objectives:

1. Students will display knowledge of medical terminology symbols, abbreviations, prefixes, suffixes, and word roots.
2. Students will demonstrate an understanding of confidentiality, HIPAA, medical record components, and the different types of health care setting.
3. Students will explain the function and anatomy of the integumentary, musculoskeletal, cardiovascular, lymphatic/immune, respiratory, digestive, urinary, reproductive, endocrine, and nervous systems.
4. Students will identify and describe the organization, common pathologies, diagnostic procedures, and therapeutic procedures associated with each body system.
5. Students will exhibit familiarity with pharmacology, mental health, diagnostic imaging, rehabilitation services, surgery, and oncology.

Considerations: This online course is not self-paced!! You have to meet deadlines and complete work throughout the week! The online course setting is more flexible in that you can do your work from wherever you have internet access and you can do it at any time during the day. Keep in mind that you should be spending approximately 8-12 hours a week on this course. Also, because this is an online course you should not expect for it to be any “easier” than a traditional face-to-face course. On the contrary, it may be more demanding because with an online course you are forced to be more active in your learning versus passively attending a face-to-face class and just taking it in. All communication in this class is done

via reading and writing.

Through prior or concurrent undergraduate courses, students are expected to be familiar with the composition of basic oral and written communications. Successful students will produce clear, fluent writing demonstrating proper language usage, spelling, sentence structure, punctuation, and the like. In addition, students are expected to have access to and working knowledge of Adobe Acrobat Reader, Microsoft Word, Excel, and PowerPoint, and the ability to create and save files in Microsoft Office file format. **All documents must be submitted in .doc, .txt, or .rft formats only!** *Any other formats will not be accepted and a zero will be awarded for that submission.*

Although many smartphones allow internet access, many tools that are incorporated into this course are not functional on the smartphone. To better serve you, it is not recommended that this online course be accessed through the smartphone.

Requirements: Each student is expected to read the weekly chapter in a timely manner. All assigned activities are based on a combination of three things: the companion website, the textbook, and the lecture notes. A firm understanding of the material is **highly** suggested before attempting to complete any assigned activity!

In this online course, regular participation in the discussion board is necessary! It allows your instructor and classmates to get to know you. Each week you will be required to develop a story that contains medical terms (proper usage is required!) covered in the weekly chapter. **Your posts must be original and thought provoking.** This exercise is designed to give students the opportunity to use medical terms in the correct fashion, thus conveying important medical information to those involved in the situation. It is also designed to help further your understanding of the different areas you could potentially work in once you have completed your program.

There will be weekly discussions (each worth 20 points), chapter homework assignments (each worth 20 points), exams (each worth 100 points), and a cumulative final (worth 200 points).

Course grading policy: Lecture grades will be based on the percentage of points earned (100 or higher = A+, 99-91% = A, 90% = A-, 89% = B+, 88-81% = B, 80% = B-, 79% = C+, 78-71% = C, 70% = C-, 69-60% = D, below 60% = F).

Assessments: There will be a total of **FOUR** 100 point lecture exams and a 200 point **CUMULATIVE FINAL** in this class. Assessments may contain multiple choice, true/false, matching, short answer, and/or labeling

questions regarding information discussed in the textbook and lecture notes. **All assessments will be taken online through the companion website (MyMedicalTerminologyLab).** You will have **one** opportunity to complete each assessment within the week they are assigned. **Every student must take the cumulative final during the scheduled time – no exceptions!**

Make sure you understand the concept of availability and duration (discussed on the **Start Here page**). Assessments will be available for **one full week** (Wednesday 12:00pm – Wednesday 12:00pm MST). The computer will not allow you to submit your answers if you go beyond the allotted amount of time. And you cannot stop an assessment once you have started it, so please make sure you are ready before you start!

Homework: There will be a total of **THIRTEEN** 20 point chapter homework assignments in this class. Homework assignments may contain interactive activities, reading questions, and/or coaching activities regarding information discussed in the textbook and lecture notes. **All homework assignments will be completed online through the companion website (MyMedicalTerminologyLab).**

You will be given **three attempts** to answer each homework question correctly. If you miss an assignment deadline for some unforeseen reason, you will be allowed to submit late work after the deadline. ***The submission of late work only applies to Part A*** **A 15% penalty on late submissions of Part A will be applied.** The submission of late work **does not** apply to any of the lecture exams. If you miss a lecture exam you will receive a score of zero.

Discussion board: The discussion board is the only platform we have to interact and have a ‘conversation’ about the topics we are covering. All students are required to **actively** and **regularly** participate in these conversations! During the first two weeks of the semester (Week 1 and Week 2) there will be two – three critical thinking questions for you to read, analyze, and critique. You must post a response to **TWO** questions. The responses you post will be your opinion, so **do not** copy and paste (i.e., plagiarize) from the textbook, a website, or another student! If you plagiarize your responses in any fashion, I will remove it from the discussion board and you will not receive credit for that week’s discussion board. Once you have posted your original responses to two of the critical thinking questions, you must respond to **FOUR** other students. The two critical thinking question responses are worth 10 points (5 points each) and the four responses to other students are worth 10 points (2.5 points each). The **quality** of your contributions to the weekly conversation matters and will factor into the points you earn. Each of your six postings per week will be graded according to the rubric discussed in the Discussion Board Guidelines, so please read them thoroughly!

During the rest of the semester (Week 3 – Week 13) you will be creating a story based on medical terms covered in that week’s textbook chapter. Your stories can be about anything you want – **the more creative the better!** Every story must be about a medical issue or issues surrounding a patient or multiple patients. You can write a story based on a medical situation you’ve experience or one you created. *** If you write about a medical situation you’ve experience, please make sure you do not use the real names of anyone involved – privacy is vital in the medical field! *** Each story must be **at least 8 complete sentences** in length and contain **at least 10 medical terms**. You can only use each medical term **once** in your story for credit and each medical term must appear in capital letters (e.g., ectomy is not a full medical term, but HYSTERECTOMY is). Please make sure you include things such as the type of physician the patient will see, the procedures used, and diagnoses that required them. Your story cannot simply be about the definitions of 10 medical terms!

Once you have posted your original story, you must respond to **FOUR** other students. In your responses to other students, you should talk about things such as whether or not they used their medical terms properly, what medical terms could also fit into their story, and your overall opinion of the story they created. The story you post will be worth 10 points and the four responses to other students are worth 10 points (2.5 points each). The **quality** of your contributions to the weekly conversation matters and will factor into the points you earn. Please remember, if you only read one or two posting you will miss out on the entire 'conversation' that is occurring...thus the discussion board would be pointless. You **must** actively participate (post and read) for it to be an effective resource!

Each student must post **their story and respond to at least one student by Saturday 11:59pm!** If you do not post in the discussion board by the middle of the week (Saturday 11:59pm MST) you will automatically lose 5 points off of your total discussion score for that week (regardless of effort). Waiting until the last minute to participate negates the entire purpose. It also denies your fellow classmates the chance to discuss these important topics with you. **Please** be an active participant!

When you are ready to post your story, you will **create a thread** for that chapter. Please make sure you add the correct thread to the correct chapter! When you have found a student you wish to respond to (i.e., further the conversation), you **must reply to their posting**. Your discussion posting should enhance and further the discussion. **Do not** post simplistic responses such as "I agree", "good point", or "I don't know" for this type of response will not earn you credit.

Discussion topics will be active for **one full week** (Wednesday 12:00pm – Wednesday 12:00pm MST). After that, the topic will be locked and points assessed. **Please** check the discussion area more than once a week so you can respond to those students responding to you.

Course Behavior: As this is an online class, all classroom communication will be through the written word. With this in mind, please make sure you remain respectful and tolerant of others' opinions. Tone cannot be deciphered from writing. All opinions are valid in this classroom! **Diversity and open-mindedness are valued and expected!**

You may become discouraged with taking an online course, especially if this is your first one. I truly hope this does not happen! However, if it does please talk to me immediately.

Response Time: I will do my best to answer emails within 24 hours of receiving them. **I will not be available to students on the weekends (Saturday and Sunday)**...those are the two days a week I take off.

After an assignment or assessment deadline has passed, I will begin grading. You can expect to have your graded assignments and assessments returned by the following week. **Please give me the full week to complete grading before you inquire about your grade!** If more than a week has passed, feel free to start asking questions about your grade.

FERPA: As an institute of higher education there are certain laws that UNM Valencia and its instructors are regulated by. The most important law college instructors must follow is FERPA. FERPA (Family Educational Rights and Privacy Act) protects the privacy of student education records. I cannot (by law) discuss any information about a student, their situation, or their progress with anyone *except* the student themselves. If you are taking this course with a spouse, sibling, or relative I cannot discuss anything with them except issues that pertain to them personally. Please do not ask someone else to contact me in regards to a situation you are experiencing. You must discuss your issues or personal situations with me yourself! Course Exceptions: Exceptions to the rules in this course will **only** be made in emergency situations. Hopefully no one will experience an emergency situation this semester! However, sometimes it is out of your control. If you experience an emergency (i.e., a death in the immediate family or a hospitalization) you **must** inform me of the situation **within 48 hours**. You **must** provide **written documentation** (including dates and times) before arrangements will be made to complete any work missed during the emergency. Once the situation has been taken care of, you will have **one week** to complete and/or submit any missing assignments or assessments. If you fail to inform me of your situation, you will lose your opportunity to make up those lost points.

Student Code of Conduct: All students will abide by the academic integrity standards described in *The Pathfinder*, UNM's official student policies manual. **Do your own work!** Cheating or any other form of academic dishonesty will not be tolerated!
