VALENCIA FACULTY NEWSLETTER | OCTOBER 2020



To my Faculty Colleagues,

I want to commend all of you for your work during these trying times. While we assume that we will continue into the Spring operating with a significant percentage of classes online, I look forward to the possibility of a safe vaccine being available sometime next year.

Until then, we have to keep on, giving our students the best academic experience we can. As I have shared with you, in addition to our TRiO SSP Grant which will serve 144 low-income, first generation students, and

students with disabilities, we also have been awarded a Title V Hispanic Serving Institution Grant which will support us in creating guided pathways for our students.

The search for the project director of the TRiO Grant is underway, and Veronica Salcido will lead the Title V Grant. Elaine Clark will lead the faculty effort on this grant. When we have more specifics about how each grant will function, we will have a meeting to speak with faculty and staff about the details of the grants.

I am happy to report that our Provost, James Holloway, has decided to maintain our current operating agreement fee of 3.6% which we pay to UNM-Main Campus. If agreed to by our Advisory Board, it will remain at this level for the next two years.

On October 20, the Legislative Finance Committee will meet and discuss higher education. We anticipate the discussion will center around their perceived need to "right" size institutions of higher education in the state. Our respective associations, CUP, NMACC, and NMICC are working on letters to present to the committee. As you may know, two-year colleges have seen enrollment declines in the past decade. And low-income

students graduate at rates much lower than students with high family incomes. According to a report by Opportunity America, The Indispensable Institution, only 11.8% of students born in the 1980s from families whose incomes were in the lowest 40% graduated from four-year colleges.

New Mexico's Branches provide critical access to higher education as well as paths to careers and transfer to four-year institutions. My fellow Chancellors and I are working with the Provost to create a unified message from the Branches and Main Campus to present to legislators as we anticipate January's Legislative Session.

One final request. Please vote on two bond items in the upcoming election. Bond B provides resources to local libraries, public school libraries and college libraries. Barbara Lovato anticipates that our library would receive in the vicinity of \$16,000 for library materials should Bond B pass. Bond C will provide resources for higher education capital improvements. UNM-Valencia is on Bond B for \$1.5 million in improvements to our fire suppression systems, especially related to the four oldest buildings on campus.

Again, many thanks for all you are doing for our students — please stay safe and well.

Because it is unlikely any vaccine will be widely distributed before the spring or summer, the spring semester course array will look largely like it does now, with only a few courses taking place in person. This will mean that our efforts in online learning on a large scale will have reached the one-year mark – ONE-YEAR. Considering how it has played out, I feel like we are doing remarkable work. At this point, the transition back to more face-to-face may seem just as strange as our initial transition to online!

Faculty Academy takes place at 10:00am on Friday, October 9, followed by Faculty Assembly at 1:00pm. Within a week or two, construction will start on campus at the Student Center, classroom A-101, and outside near the Health Sciences and Career Technical buildings for infrastructure and beautification. There will be some adjustments to entering and exiting that building, since A-101 is the focus of activity.

Professor Heyward will follow the lecture by giving studio visits to graduate students to chat with them about their work.



Printmaking at UNM-Valencia

As a professionally trained Master Printer, it has always been my dream to teach a printmaking class at Valencia. Printmaking is why I ended up in New Mexico! I moved here from Brooklyn 22 years ago to study at the Tamarind Institute of Lithography, a school completely devoted to the technique of lithography and the only such school in the world. After this professional training program, I became a Master Printer at Pyramid Atlantic Press in Maryland outside of Washington, D.C. As it happens, though, I ended up back in New Mexico to earn my MFA at UNM in Electronic Arts (Land of Enchantment/Entrapment...?). For the past 12 years at UNM-Valencia, my focus has been in the digital and electronic arts, although I have had the pleasure of teaching darkroom photography in the studio here and there, which I absolutely love. There is nothing quite like being in a studio making with students who are passionate and sense the magic of creating art! This past semester, my Chair, Justin Bendell, and I made a plan to offer printmaking this Fall 2020. I was so excited! Unfortunately, the pandemic arrived and I did not think taking Printmaking fully online with haste was really fair to our students, so the class was cancelled. I became part of some online art teaching Facebook groups, and learned about this amazing Open Press Project, though! Over the past month, I have been working with James

Hart on manufacturing a 3D Printed Personal Printing Press, the design of which is offered for free through this Open Press Project. After a good 2 weeks of studying and a solid 4 days of printing, I was able to put together the first press! Although we have decided not to offer the printmaking class this coming Spring 2021 semester, I am hoping to manufacture around 16 of these printing presses to checkout to our Valencia students next academic year in the hopes of offering the class, even if it is fully remote!





M(athematics), E(ngineering), C(omputer) S(cience) **Division (MECS)**



We have been busy in the MECS division (and beyond)!

Nancy Engler, our engineering faculty member, continues her work to promote and increase numbers in our AS in Pre-Engineering. She plans to attend the annual statewide engineering articulation meeting in November.

Andy Taylor, one of our brand-new math faculty members, is conducting a pilot Intermediate Algebra Rewind. The Rewind provides two days a week of targeted tutoring help for those students who are struggling in Intermediate Algebra. This pilot is funded by a small grant we received from Facebook.

MEGS DIVISION CHIRK ELAINE W. CLARK, DIVISION CHIRK CLARK, DIVISION CHIRK This past summer Ariel Ramirez, Cindi Goodman, Michelle Godfrey, and I met to work on the design of a rejuvenated Math 099: Pre-Algebra course. This redesign will trickle up through our Math 100/021/022 Introductory Algebra course and then into our Math 1215/X/Y/Z course. The design incorporates project-based learning into the course with less emphasis on memorization and exams, and more emphasis on application and understanding of concepts. The work this past summer was funded by our Title V: Next Gen grant. Ariel, Cindi, and Michelle are working this Fall on the redesign of Math 100 to roll out in the Spring. Their efforts are funded by that grant from Facebook. The redevelopment of the Intermediate Algebra courses will occur over next summer-funding to still be determined.

Greg Barnett, Andisheh Dadashi, and I are working on designing a new Associate of Applied Science in Computational Mathematics. We hope to have this degree program proposal go through Curriculum and Undergraduate Committees this Fall and Spring. The program provides students with courses in computer programming, computational modeling, and data science. The courses should transfer right into Bachelor's degree programs at main campus in Computer Science, Applied Mathematics, and/or the new National Security Studies programs.

A couple of weeks ago I attended an NSF funded conference on programs to support Rural Hispanic Serving Institutions. We discussed ways in which we could better serve our students who come from Latino/a or Hispanic backgrounds. One of the two keynote speakers was Tanya Hodges from University of Arizona in Yuma. She shared some of the things they have done to increase enrollment and retention of Hispanic/Latinx students in their two-year programs. One in particular that stood out was their Agricultural Technology program. The other keynote speaker, Melissa Salazar, lives right here in New Mexico! In Espanola to be precise. She had a lot of cool things to say and I hope we can invite her to come to Valencia campus to present her thoughts and ideas on how to better serve students at rural HSIs.

Another thing I learned about recently is a really cool MOOC that is on EdX called The Science of Everyday Thinking. I'm about halfway done with the course. There was one unit so far that really struck me about how we learn. They talked about how cramming for tests and putting information in short-term memory can increase performance in the short term but does NOT increase learning. I've got all kinds of ideas about how to teach better from this course. I'll give you the information if you are interested.

Our group of First Year Full-Time Faculty are meeting regularly, once a month between Faculty Academy and Faculty Assembly. The participants (not in any particular order) are: Precious Andrew (Math), Andy Taylor (Math), Piotr Filipczak (Chemistry), Tammi Duncan (Biology), Sarah Heyward (Art), and Scott Kamen (History). Scott is really in his second year but he's joining us. We meet to talk about teaching and other mentoring type things. So far Melanie Sanchez-Dinwiddie, Justin Bendell, and I have been the mentors in the group. Our time is short, and we like to focus on the ideas, thoughts, and concerns of the first-year faculty, so probably would prefer not to have a ton of other people join us.

Piotr Filipczak | Assistant Professor of Chemistry

Welcome to the fall 2020 semester! I am excited for the opportunity to be an Assistant Professor and co-Principal Investigator (co-PI) for the Reaching Rural STEM Students (R2S2) program at UNM Valencia. My teaching contribution includes General Chemistry for STEM Majors courses, both lecture and laboratory, and Introductory Chemistry for Non-majors. As a STEM faculty involved in R2S2 program, I am seeking candidates who would like to conduct a research project in the field of biochemistry of nucleic acids that focuses on long non-coding RNAs (lncRNAs), a novel class of regulatory molecules critical for transcriptome of living organisms. Please do not hesitate to contact me

if you have a student with an interest in this type of research. As a co-PI for R2S2, I will be happy to address any of your questions regarding ongoing or possible projects across various fields of STEM offered at UNM-Valencia, and to navigate students toward faculties that could mentor you in these areas. My personal interest in STEM began at the age of 19 when I became a biotechnology major at the Division of Biology and Environmental Protection of the University of Silesia (UofS) in Katowice, Poland. Furthermore, since the age of 21 I committed myself toward training and conducting basic and translational biomedical research with an emphasis on lung cancer. In 2005, as a 2nd year student at the UofS, I began my training in the biochemistry of cancer at Maria Sklodowska-Curie Memorial Cancer Institute (MSCMCI) in Gliwice, Poland.

After completing my MS in biotechnology at UofS and PhD in medical sciences at MSCMCI, I continued my scientific career through a postdoctoral fellowship at Brigham and Women's Hospital (BWH), Harvard Medical School in Boston, MA. My research focused on mechanisms of acute respiratory distress syndrome and other respiratory diseases. This research soon transitioned into a collaborative project between BWH and Lovelace Biomedical Research Institute (LBRI) in Albuquerque, NM, which gave me an opportunity to conduct research at both locations. Finally, for the last six years I was working as a research scientist at LBRI studying biochemical pathways and novel treatment options for LAM disease and the role of the TET1 gene in lung cancer malignancy. Simultaneously to my research activity, in 2016 I become a part-time faculty at UNM-Valencia which allowed me to get familiar with this fantastic learning arena. I am now proud to serve students of UNM-Valencia with my knowledge of chemistry and with my research experience as a full-time faculty. Outside of my professional activities, I explore broad opportunities provided by New Mexico public lands for hunting, fishing, mountaineering and camping, and, together with my wife, we began introducing our two-year old daughter into the outdoors as well. The September reading for our Reading Club was "Principles of Good Practice in SoTL" by Peter Felten, a historian and Assistant Provost at Elon University. Felten is also the Executive Director of the Center for Engaged Learning and the Center for the Advancement of Teaching and Learning.

Felten listed five principles of good practice in the scholarship of teaching and learning. These principles can be applied to both online or F2F classes. The first one focuses on how students learn; or framing it differently, the inquiry is about how teaching and teachers influence students' learning. This reminds me of a talking point at a recent roundtable that I attended at CDL at Main-how does our background affect how we teach? The second principle of good practice is grounded in evidence-based literature that is "rooted in particular classroom, disciplinary, institutional and cultural context" instead of the informal networks of scholars and their casual conversation on student learning (Felten: 122). The third principle of good practice is methodologically sound. This refers to the "intentional and rigorous application of research tools that connects to the research question...student learning" (Felten: 123). Fourthly, the good practice principle requires us to partner with students in every single step when we study their learning. The final principle involves sharing that occurs either in the community of practice or published journals in which colleagues' constructive critiques are being taken seriously.

Our discussion involved sharing of our reflection on our individual teaching philosophy and pedagogy. Needless to say, it was intellectually stimulating. If you are interested in discussing more on SoTL and why we practice it, Soledad and I welcome you to a TLC session on "A Community of Practice: What is SoTL and Why?" sometime this month.

As our Reading Club continues our discussion on good practices in October, we will examine the "Seven Principles for Good Practice in Undergraduate Education" by Arthur Chickering and Zelda Gamson. Let me know if you want to join us and I will send you the link. Hope to see you there. Till next month... \bigcap

Faculty responses to Beth Davila's workshop:

Laura Musselwhite:

I enjoyed it very much. I liked how she organized the workshop – just enough discussion compared with small groups compared with her insights.

Her approach is different from what I have done in the past, but I think it's good. The workshop made me think about how I need to revamp a lot of elements of my class -I've been working on changes, but it is still too old-fashioned of a construct, I think. Gave me lots of food for thought.

Scott Kamen:

I found the workshop to be immensely fruitful. I'm not sure what I expected it to be, but it was different from what I expected. I hadn't given much thought before to students' dialects and linguistic backgrounds beyond their overall abilities in English. It gave me a lot to think about as far as how to approach, comment on, and assess or not assess grammar issues. It was also really interesting to hear what the large number of English faculty at the workshop had to say. The discourse in English circles is pretty different from that of History circles, which made the overall conversation really enlightening for me.

Some reflections from our tutors:

"I learned today that growth mind set is about thinking two different way or how one views a situation in a positive manner rather than a negative way. When we meet challenges, the more effective way of dealing with this is to think about the challenge as an opportunity."

"I was surprised that learning styles have no scientific backing. I do think there are better ways for some people to learn but knowing this maybe will help me encourage people to move out of their set ways of learning and help them adopt other styles into their education. I know for myself, I am always down to try anything to improve my study and learning skills."

"This tutoring training was very helpful for me because I am struggling a lot this semester to concentrate and study. Something interesting we talked about in the breakout rooms was me having to watch labs on YouTube, and I was one click away from watching another video that wasn't on topic. Something I will incorporate in my tutoring and myself is telling students to make their own note cards. I think it is important and it helps with quick studying sessions."

How You Can Embed a Writing Consultant in Your Class

Any instructor—not only in English—can have a Writing Consultant embedded in their classes.

What this means:

- Instructors adding consultants in the course as Builders
- Consultants reading assignments and preparing to support students
- Strong communication and clear expectations between tutors and instructors.

What it can mean:

- Instructors enabling consultants to reach out to students in several ways, including through
- Course Messages,
- Announcements,
- An "Ask a Tutor" forum in Discussions, and
- specific spots in Learn where tutors can provide information about themselves and resources

With or without embedding consultants as builders, the following collaborations are possible:

- Consultants joining synchronous Zoom class sessions with students
- Consultants doing brief presentations on tutoring services
- Instructors providing extra credit for working with consultants.

Finally, in coordination with Patricia Gillikin, Writing Center Director, instructors can ask students to meet with a tutor as part of an assignment sequence. The coordination will make sure that too many full classes of students don't attempt to make appointments in the same week, and integrating working with tutors into coursework for one assignment often "breaks the ice" and shows students what tutoring is like, such that they are more inclined to work with tutors in the future.

Consultants at Webinar: Racial Justice and Online Writing Center Praxis

On Oct. 2, Patricia Gillikin and consultants Allie Hefner and Velanie Chavez attended the webinar "Racial Justice and Online Writing Center Praxis," offered by the Online Writing Centers Community (OWCC). The presenter, Zandra L. Jordan, incorporated images of murals showing Breonna Taylor and George Floyd. She asked participants to describe their racial justice values and commitment in the areas of linguistic diversity, racial literacy, representation, tutor training and praxis. Then she invited visions of "the racially just future that you want to see for your online writing center" and actions plans for moving toward those visions.

FACULTY SENATE UPDATE ALEXA WHEELER AND BARBARA LOVATO

As UNM-Valencia Campus Faculty Assembly Representatives on the UNM ABQ Faculty Senate, we would like to give you an update on the items discussed in our recent Senate meeting that will also affect our Valencia Campus.

President Stokes' Report:

- Health Information Important to continue to share
- New EVP Health Sciences expected to be announced soon

Budget:

- no expectation for additional cuts this FY
- expected 5% cut for next FY
- evaluating administrative costs for potential cuts

Student numbers:

- Freshman numbers are up
- Improving retention/graduation

Provost Holloways Report:

- Enrollment at UNM ABQ campus is up by about 7%, but enrollment is currently down about 34% at Valencia Campus.
- It is not known whether Fall or Spring athletics will happen or not- these hinge on the ability for UNM to do frequent, rapid testing which is not in place yet.

Campus openings:

- Žimmerman Library about 150/day
- Centennial, Fine Arts and Law Libraries open
- Student Union Building and La Posada open at 25% capacity indoor seating
- October 5: Johnson Center Gym open.

Faculty Senate President Finnie Coleman's Report: He mentioned how he is so glad to have a Branch Campus Ad-Hoc Committee (which

we are on) and is looking forward to working with branch campuses this year.

Take a look at Policy C07 in the Faculty Handbook and reach out to us, Alexa or Barbara, on what comments you would like us to provide to the Senate – the Senate will be taking comments in the October meeting.

Two items to consider:

- Should C07 (and related policies) be moved from Section C - Faculty Rules and Benefits to Section B - Academic Freedom & Tenure.
- What changes do we want to see in Policy C07?

Take a look at the Regents' Policy Manual -Section 1.5: Appeals to the Board of Regents and reach out to us, Alexa or Barbara, on what comments you would like us to provide to the Senate- the Senate will be taking comments in the October meeting.

One item to consider:

• The Regents are trying to reduce the 30day timeframe for an appeal to an only 10-day timeframe.

Concerns:

- Title IX cases could fall through the cracks since there are often quite a few, which could allow case numbers to just go down and/or away.
- Should we be truncating opportunities for university members to appeal. Or should we be looking at a policy change to streamline the process instead of the timeframe?

Finnie is working on trying to get more faculty senate representation on the Budget Committee.

As a Faculty Senator and Member of the Faculty Senate Instructional Technology Use Committee (FSIT) at the ABQ Campus...

I would like to give you an update on the items discussed in our recent meeting that will also affect our Valencia Campus.

As you may have heard by now, the Provost Taskforce on Redesigning the University, has put in a Request for Proposal (RFP) for the evaluation of the Learning Management System (LMS) that UNM subscribes to, which is currently Blackboard Learn. Although I cannot discuss the 3 LMS candidates that the committee is considering at this time due to a confidentiality agreement, the goal is to determine which LMS to purchase for the UNM campuses by the end of this Fall 2020 semester. No matter what, we are going to have to start using a new system because Blackboard, as it is right now, will no longer be supported come Fall 2022. If, in the process of evaluation, it is determined that we will continue with the Blackboard environment, it too will be a different platform with the new update. So, in any case, we will all have some learning and training to do.

I recently sent out a forwarded email from the Center for Digital Learning (CDL) that is requesting faculty sign up to participate in the evaluation process of the new LMS. I highly encourage as many of you who can test out these environments to please sign up within a week! Here is the link to sign up again just in case: <u>LMS Evaluation and Testing</u> <u>Sign Up.</u>

By participating in this evaluation process, UNM-Valencia Campus will have a voice in this very major decision that will affect each of us and all of our students. I know there are many of you who only began using Blackboard Learn during this pandemic, and the idea of change already can be a stressful thought. To alleviate a little bit of that stress, here is a quick overview of the timeline on implementing a new LMS:

Happening Now:

• Configure "example" courses (or sandboxes) for the semi-finalists for all who signed up to evaluate

October 2020:

- Semi-finalists will conduct demonstrations and explain the LMS (open to all faculty, staff, students)
- Evaluations for those who signed-up to test the LMS's will be due, and a series of 90-minute, one-on-one interviews will be conducted by the CDL to obtain richer, more detailed thoughts on the environments ideally 15 each of faculty, students & staff

Late Fall 2020:

• final selection on LMS will be done

Late Fall to Early Spring 2021:

• course migration planning, student and faculty support planning (more staff will be hired if needed in order to migrate and train/support faculty from Blackboard to the new LMS)

Spring & Summer 2021:

• implement Banner, 3rd part tools, vendor integrations, system configuration, custom development, build documentation + training + support to distribute on the UNM website

Fall 2021:

begin course migration for select faculty/courses to pilot Spring 2022

Spring 2022:

live courses in new LMS for select faculty/courses

Summer 2022:

• all courses will be in new LMS, final course migration for all other courses

Fall 2022:

• every course/faculty member will be delivered in the new LMS

As you can see, we have about 2 years before everyone is going to have to begin using the new LMS. But- which LMS is going to be determined within the next 3 months- that is soon! I would love to see as many of you participate in this LMS evaluation process as can. Feel free to reach out to me with any questions, and I will be keeping you all posted as I go through this process with the FSITUC. \bigwedge_{I}

- Alice Letteney responds that she understands that it is a chore to have to go to campus just to install or update software, but Robert is willing to meet in ABQ to help people with their computer.
- Soledad requests an explanation of what administrator rights are so that everyone understands. She explains that it does not give rights to the network, it simply allows you to install important updates and software without help from IT.
- Alice mentions that some staff are tied into the VC network even when their computer is at their own home. She recommends setting up a zoom meeting with Jon and his people, and Laura and Alice, and Greg. Set it up so that any faculty member can join with us.
- Laura mentions that we might be conflating the two issues, admin rights and VPN software for accessing the UNM network from home.
- Anticipating a five percent budget cut in January.
 - Trying to figure out how to address this.
 - ${\rm o}$ Base budget is now the reduced budget from the June special session.
 - $_{\odot}$ Expect to be looking at a cut of over \$250,000 in the January session.
 - \odot Alice has spoken to the provost about this. Things we need to do on a system wide basis.
 - o October meeting to discuss "right sizing" of our campuses.
 - Currently operating in a situation where we do not need to fill certain vacancies. Maintenance, police officer, etc.
 - \circ Will look at faculty vacancies very carefully to decide whether they need to be filled.
 - Very fortunate, stable, have a lot of grant money.
 - \odot Has told the provost that this year is a "lost year".
 - Mentions some students who were main campus students who are now taking all of their classes from Valencia instead. Alice argues that they started at VC, moved to main, and then wanted to be home after pandemic started so came back to us.
 - NMSU prevented any main campus student from taking branch campus courses this semester, which decimated the branch campuses.
 - \circ Heather brings up core courses from humanities that have increased their caps from about 40 to 100 on main campus.
 - \circ Alice says branch campuses are working very hard to maintain our status as we move forward.
 - \circ Joseph Poole comments on what NMSU is doing.
- 5. Dean of Instruction Report Laura Musselwhite (10 minutes) (10)



- Clarification. Branches still exist at NMSU, just changed the top structure, firing all the presidents of the individual branches.
- Limited number of students teaching and learning on campus, rest online.
- Students are obeying all protocols, so that is good news.
- Not a lot of discussion about Spring semester yet. Discussion has been centered on keeping things the way they are now.
- Heard a little discussion today about maybe not having Spring Break, or not have it be the same. Not wanting students to go somewhere and then come back to campus.
- We have gotten a good start with not replacing people to save some money.
- Justin Bendell asks if Laura knows the status of the union negotiation status.
- Laura says there was a break over the summer in the normal negotiation. Got through the talk about coming back to campus in the Fall. Have had two sessions, back to regular bargaining. Moving along, but slowly. The two sides are going to talk more about philosophy of what the union is aiming for over the next two sessions. Union wants to change everything, management wants to know what needs changing to see if they can address it.
- Julia So asks about compensating faculty because they have to teach from home. On main campus, it depends on the department, not the college.
- Laura says the \$40 a month started as intended for staff, and several staff had been taking advantage of that. Anybody can request it, but maybe not as needed for people who had already been teaching online. It has become too expensive for main campus so they are trying to discontinue it. Laura will ask Rick Goshorn about it again and see where to go from there.
- Julia recommends that if a policy is approved, that it be widely known to everyone to facilitate greater comradery among staff and faculty.
- 6. Treasurer's Report Cheryl Bryan (1 minute) (2)
 - Information from Stephen Takach. We have about \$27.15 in the snack fund.
 - Elaine says money is allocated to Faculty Assembly every year and it hardly ever gets used. Wonders if we could use that to help adjunct faculty in some way, perhaps upgrading their internet or something similar.
 - Jerry says yes, we should think about that.
- 7. Teaching and Learning Center Update Soledad Garcia-King (5 minutes) (3)
 - All workshops will be on zoom, calendar has been sent out.
 - Set up some open lab times as well in conjunction with Alexa Wheeler
 - Robert and David are working diligently to keep everything going, helping people check out laptops and such.
 - Hopefully we can get to the point where we can download the software that we need without having to come to campus.
 - One on one assistance face to face available upon request.
 - Elaine mentions Alexa Wheeler has been working hard on faculty website, wants to point people there to find information if they need it.
- 8. FAIT Update and New Statement Justin Bendell (10 minutes)

 - Timelines for when things will be resolved
- Want admin rights for faculty teaching from home on UNM machines.
- VPN so that faculty can have access to all that they need for scholarly work.
- Reminder that laptops are available for faculty to check out.
- Request for compensation similar to what was given to staff and tutors for increased internet/phone and materials cost due to working at home.
- Nancy Engler wants to address the best way to contact computer support. Email does not always work. Email and get nothing, repeatedly. And you don't know if you are in a queue, or if they forgot about you.
- Heather says that's how they do it, the mystery, the vortex of IT. No accountability, no system at IT. Always been like that.
- Elaine says Robert and David are pretty responsive, but if everyone goes to them first, then they might get inundated with too many requests.
- Juliette wonders exactly what is the procedure for checking out a laptop. She has heard people alluding to it, but doesn't know the details.
- Soledad says you would contact Robert Castillo to get a form to check out a laptop. He would have you either come to campus or meet somewhere off campus to fill out the form and give you the laptop and record it in the system.
- Julia mentions some faculty have checked out a laptop from the library directly.
- Elaine Clark moves to endorse policy
- Heather Wood seconds
- Endorsing the statement rather than approving a policy, Julia So clarifies.

options are. Alexa does not think anything is changing for at least two years.
