### **Course Objectives:**

An introduction to basic nursing skills with an opportunity for students to explore a variety of patient needs. Basic nursing skills will be applicable for patients in need of acute or chronic long care. Patient care for those in Home Health, Hospice, Assisted Living, or Mental Health facilities will also be introduced. Successful completion of the course with a score of 80% and being 18 years or older, permits students to take the NM Nursing Assistant certification exam.

The 96 hours of classroom and lab skills practice enables students to obtain introductory knowledge of basic theoretical areas: Anatomy & Physiology, Aging, Patient Safety, Communication skills, Cultural Competency, Medical Terminology and a variety of other subjects. This course will also permit students to learn and practice basic nursing skills in a laboratory and healthcare setting. A 32 hour supervised clinical experience in a health care facility permits students to perform safe, basic, patient care skills and utilize the basic nursing knowledge attained.

**Teaching/Learning Strategies:** Instruction methods will vary and include: lecture, discussion, work groups, workbook exercises and clinical skills practice. The clinical portion of this course will include demonstration of practical skills. This practical experience will take place in a 'student to patient' situation in the clinical facility setting.

## **Student Learning Objectives:**

## At the end of this course, students will possess the knowledge to demonstrate:

- 1. Basic nursing skills with an emphasis on patient safety.
- 2. Knowledge of basic medical terminology and documentation

- 3. Knowledge of basic anatomy and physiology.
- 4. Knowledge of basic patho-physiology and the correlation with CNA standards and practices.
- 5. The professionalism and competence commensurate with a basic nursing care provider.
- 6. The Nursing Process and the basic fundamentals of Nursing Science.
- 7. Knowledge of local, state and federal guidelines that apply to the healthcare industry.
- 8. Team-building and communication skills, the basics of good work ethics and job seeking skills
- 9. Preparation for the state certification exam.

### **Student Responsibilities:**

- 1. Be present, prepared and punctual for all class sessions- review Chapters to be covered prior to class.
- 2. Complete all activities as directed. [*Full credit given for homework submitted by due date.*]
- 3. - F. Obtain a completed Health Form indicating the ability to lift at least 50 pounds without assistance, up to date Immunization record, Tuberculosis test and possess AHA Healthcare Provider CPR Certification (online courses will not be accepted).

#### WHAT ARE THE GOALS OF AN I-BEST'ED CLASS

Integrated Basic Education and Skills Training or I-BEST is designed to boost student foundational reading, writing, math, and study skills so that the student can successfully complete a career-based certificate and secure living wage employment. The I-BEST program provides for 2 instructors, one trained in career content and the other in foundational skills, to work together for your success. As part of this focus on careers and foundational skills, all students will be required to complete a WorkKeys pre-test. A post-test will also be required before the end of the semester (Date TBA).

Before you entered this Certified Nursing Assistant class you had to complete a WorkKeys test. WorkKeys® is a job skills assessment system that helps employers select, hire, train, develop, and retain a high-performance workforce" ("WorkKeys," 2014) and is a test used by the City of Albuquerque and other employers to hire employees. After taking this test, you will qualify for a National Career Readiness Certificate, which you can present to current or future employers as proof of your job skills and which is issued at various skill levels, depending on your test performance.

Upon completion of this course, you will demonstrate the following foundational competencies, which are drawn from the National Reporting System's outcome measures for adult learners at the high adult secondary level:

- Can comprehend, explain and analyze information from a variety of literary works, including primary source materials and professional journals.
- · Can show active problem-solving skills
- · Show a working understanding of units and conversions
- Writing is cohesive with clearly expressed ideas supported by relevant detail
- · Can use varied and complex sentence structures with few mechanical errors

- Can read technical information and complex manuals and can comprehend college level books
- Can read text and explain a procedure about a complex and unfamiliar work procedure

<u>Attendance Policy</u>: No more than 12 hours of absence during Lecture and skills lab. Arrangements must be made by the students to make up missed work. <u>ABSOLUTELY NO ABSENCE IS ALLOWED DURING CLINICAL</u> <u>Tardiness >20 minutes results in the session being counted as an absence</u>.

*Homework Policy:* You will receive partial credit for late homework assignments if turned in the **next** class day - it will not be accepted thereafter.

<u>Grading Policy</u>: The CNA course is a Job Skills Program, unlike some courses, students cannot make a high grade simply by achieving high scores on exams and/or homework-basic nurse skill attainment is prudent. Students will be graded as follows:

Homework/class participation-10% (workbook, assignments)

Research Paper - 10% (infectious diseases subject)

Exams-15%

Skills Final -20%

Clinical Experience-30%

Final Exam 15%

<u>Electronic Devices</u>: All electronic devices must be turned off during class. Any electronic equipment brought to class must be approved by the Instructor before use in class. Unsafe, offensive or disruptive behavior in a clinical or classroom setting can be grounds for failure of class.

<u>Patient/Resident Confidentiality</u> must be maintained at all times during the off site Clinical Aspect. Failure to do so will result in immediate removal from the CNA program. Confidentiality is required by Federal law under HIPAA Regulations.

<u>Student health requirements:</u> to participate in the laboratory skills or at the clinical experience site, students must be able to lift at least 50 pounds *without* assistance. Students must return a completed health form signed by a healthcare provider (Physician, Nurse Practitioner or Physician Assistant) to Allied Health Dept Staff at UNM-VC. Students will also need to take a copy of an up to date Immunization record with documentation of the Hepatitis B series, Measles, Mumps, Varicella, Rubella, Tdap, Influenza and a current Tuberculosis test, and Drug Screen (See UNM-VC Handbook for details) for review by Allied Health Dept Staff at UNM-VC.

\*\*\*Clinical facilities require fingerprinting and an FBI background check before entering the facility for the clinical experience. The cost will be approximately \$73.30 and payable to Gemalto (payee subject to change)- none of the fee would go to UNM VC. Students are completely responsible for this procedure and the fees.\*\*\*. UNM/VC will facilitate this.

\*\*Students are to have an appointment scheduled with Allied Health Department Staff at UNM-VC for review of above document requirements and to schedule above Background Check as per UNM VC program director

Laboratory Skill practice and Health Care Facility Dress Code: Students are required to dress professionally. This will include scrub uniforms with white or mostly white closed toe, *clean shoes*. Tattoos must be covered. Jewelry should be *conservative*: a watch, wedding ring or a simple ring on one finger. Earrings (one per ear) should be of the stud nature and not extend beyond the ear lobe. No other rings/studs are allowed (eyebrow, nose, or tongue). For safety reasons, chokers, necklaces, bracelets and dangling earrings shall not be worn. Chewing gum is not acceptable during lab practice or clinical portion. Perfumes, after shave lotions and scented hair sprays are offensive to most patients and should not be worn. Hair, beards, mustaches and sideburns must be neat and trimmed at all times. If hair length touches the collar, it is to be held back and away from collar. To avoid injury to patients, fingernails are to be short, clean and well manicured and natural. NO ARTIFICIAL NAILS OR GEL NAILS; NO CHIPPED, PEALING, OR CRACKED POLISH ACCEPTED.

Gait belt
Watch with a second hand
Adult size blood pressure cuff

Stethoscope Small notebook and black pen School picture ID

Upon successful completion of the CNA course (overall grade is 80%), you will be eligible to take the NM State Certification Exam. Payment for the exam <u>must be in the form of a money order or cashier's check</u>, specifics regarding payment to follow. (Personal checks or cash not accepted.)

<u>IN SUMMARY</u>, the following MUST be maintained in a portfolio to be kept by the student. The student is responsible for taking the portfolio to the clinical setting. The portfolio will be periodically checked by your instructor prior to clinical experience:

- *CPR* for HealthCareProviders (BLS) card, current.
- Department of Health Forms
- Completed health form indicating that you can lift 50 pounds without assistance, a copy of an up to date immunization record with documentation of the Hepatitis B series, 2 Measles, Mumps and Rubella (MMR) injections, 2 Varicella (Chicken Pox), current Tuberculosis test, Tdap and Influenza. Current Drug Screen.

## **COVID SECTION**

## **Respect the UNM Community by Preserving Health**

You have the ability to prevent the spread of COVID-19 and to preserve the health of fellow students, your instructor, staff and the community by following UNM health protocols. Mask Wearing Accommodation: Individuals with a documented disability or diagnosis may seek accommodation with the UNM Accessibility Resource Center (ARC) (arc.unm.edu). Individuals do not need to reveal private information to an instructor. ARC will require documentation of health requirements, which will be kept confidential. The instructor will be informed only of any need for accommodation.

Consequences of not wearing a mask properly: Unless you have an ARC-approved accommodation, if you don't wear a mask, or if you do not wear a mask properly by covering your nose and mouth, you will be asked to leave class. If you fail to wear a mask properly on more than one occasions, you can expect to be dropped from the class. If you insist on remaining in the classroom while not wearing a mask (without an ARC-determined accommodation), class will be dismissed for the day to protect others and you will be dropped from the class immediately.
