Student Learning Objectives: By the end of this 3 credit hour course

1. Students will effectively communicate-expressively and receptively- at a basic level with the Deaf/Hard of Hearing individuals representing a cross-section of the Deaf community.
2. Students will demonstrate knowledge of the basic education and access issues faced by the American Deaf community.
3. Students will demonstrate knowledge of the differences between American Sign Language (ASL) and manually coded English sign systems.
4. Students will identify basic linguistic principles and describe the history of the recognition of American Sign Language.
5. Students will describe the cultural diversity and dynamics of the Deaf Community.

COURSE DESCRIPTION

This course provides an overview of signed languages, including American Sign Language (ASL), signed English as well as signing systems that are used by deaf people. Cross-linguistic and cross-cultural information is discussed with the primary focus on ASL, signed English and fingerspelling. This course exposes students to the most common manually coded signed systems and discusses their historical relevance in the education of deaf people. Historical figures and linguists are highlighted and recognized for the development and use of American Sign Language in the United States. In addition to the acquisition of basic vocabulary and grammar, this course emphasizes knowledge of the characteristics and values of Deaf Culture. This is an accelerated course that requires a great deal of discipline and practice both inside and outside of class time. Class sessions will take place at the Valencia campus. Additionally, resources and assignments will be posted on Learn. You will be required to have at least one practice partner that you connect with outside for an hour per week to have conversations using your developing skills. Each week you will submit a report summarizing what you and your partner talked about and reflecting on your personal growth. The reports will follow a provided template and will be submitted on Learn every Wednesday before 11 PM.

Federal Credit Hour Definition

Federal Credit Hour Definition: A credit hour is an amount of work represented in intended learning outcomes and verified by evidence of student achievement that is an institutionally-established equivalency that reasonably approximates not less than: (1) one hour of classroom or direct faculty instruction and a minimum of two hours of out-of-class student work each week for approximately fifteen weeks for one semester or trimester hour of credit, or ten to twelve weeks for one quarter hour of credit, or the equivalent amount of work over a different amount of time; or (2) at least an equivalent amount of work as required in paragraph (1) of this definition for other activities as established by an institution, including laboratory work, internships, practicum, studio work, and other academic work leading toward to the award of credit hours. 34CFR 600.2 (11/1/2010)

This is a three credit-hour course. Class meets for two 75-minute sessions of direct instruction for fifteen weeks during the semester. Students are expected to complete a minimum of six hours of out-of-class work (or homework, study, assignment completion, and class preparation) each week.

COVID-19

UNM Administrative Mandate on Required Vaccinations

UNM Requirement on Masking in Indoor Spaces

All students, staff, and instructors are required to wear face masks in indoor classes, labs, studios and meetings on UNM campuses, see [masking requirement](#). Vaccinated and unvaccinated instructors teaching in classrooms must wear a mask when entering and leaving the classroom and when moving around the room. When vaccinated instructors are able to maintain at least six feet of distance, they may choose to remove their mask for the purpose of increased communication during instruction. Instructors who are not vaccinated (because of an approved medical or religious exemption), or who are not vaccinated yet, must wear their masks at all times. Students who do not wear a mask indoors on UNM campuses can expect to be asked to leave the classroom and to be dropped from a class if failure to wear a mask occurs more than once in that class. With the exception of the limited cases described above, students and employees who do not wear a mask in classrooms and other indoor public spaces on UNM campuses are subject to disciplinary actions.

Communication on change in modality: The university may direct that classes move to remote delivery at any time to preserve the health and safety of the students, instructor and community. Please check your email and your UNM Learn site regularly for updates about our class, and please

Acceptable masks and mask wearing in class: A two-layer mask that covers the nose and mouth and that is cleaned regularly is acceptable, as are disposable medical masks, KN95, KF94, FFP1 and FFP2 masks. A face shield is not sufficient protection. It is vital that you wear your mask correctly, covering your nose and mouth. Removing your mask for an extended period to eat or drink in class violates the university mask requirement and endangers others.

Consequences of not wearing a mask properly: If you don't wear a mask, or if you do not wear a mask properly by covering your nose and mouth, you will be asked to leave class. If you fail to wear a mask properly on more than one occasion, you can expect to be dropped from the class. If you insist on remaining in the classroom while not wearing a mask, class will be dismissed for the day to protect others and you will be dropped from the class immediately.

The instructor will try to have a few disposable masks available in the classroom on a first-come, first-served basis.

CLASS PARTICIPATION

Class participation is essential in this class. The key advantage of class participation is that it encourages each student to be well-prepared and thus become an active, rather than a passive learner. Participation also provides you with the opportunity to gain from the experiences and talents of everyone in the class. You should feel free to ask questions, provide supportive comments, or challenge constructively what has been said. Those who participate regularly and well will benefit. If they are within one point of the next higher grade level, they will earn the higher grade. For example, if a student had an 89 average and had participated regularly and well he/she would receive an A- rather than a B+ for the course. This does not apply for grades between an A and an A+ (check grading chart below). It is expected that you will attend every class and that you will arrive on time. Recurring lateness or repeated absences will be considered grounds for removal from the course. If a guest speaker is scheduled for class, it is imperative that you arrive promptly

STUDENT BEHAVIOR

While the instructor does not expect problems when working with adult learners, a guiding principle of respect for one another will ensure a safe and productive environment. Interruptions with non-related comments are discouraged. There may be issues a student needs to discuss that would be more appropriately handled in private and outside of the classroom. There is a process in place to handle complaints...report to The Chair of CHESS and to the Dean of Instruction.

ATTENDANCE

Students are expected to attend all class sessions. Attendance is taken at the beginning of each session. Students with two (2) or more consecutive absences or three (3) or more regular absences

may be dropped from the class by the instructor. ***Student's grades will be affected by absences, dropping half a grade for every three absences.

Grades are determined from the total test scores accumulated, signing skills, class participation/assignments, and weekly partner reports.

EXAMS

Students are eligible to take a make-up exam [written only] if they (in UNM handbook)

3. Obtain the instructor's agreement that this is an emergency and that the regularly scheduled exam cannot be taken. If you miss an exam without the permission of the instructor a score of zero will be assigned. Make-up exams are granted at the discretion of the instructor, only with prior arrangement, and must be completed prior to the next class meeting (unless circumstances involved make this clearly impractical).

PARTNER REPORTS

Required outside classroom participation: selection of a partner from within the class.

A Journal entry is expected from each partner specifying location of practice, time, and a brief summary and both signatures.

Reports are collected weekly on Wednesdays throughout the semester before 11 PM.
