I. Course Description: Math 193: Critical Thinking for Math (2 credits) will develop strategies for successful achievement in mathematics including developing academic skills as a foundation for college learning, employing critical thinking skills in problem solving, utilizing multiple problem-solving strategies & methods, developing a mathematical awareness of the world and expanding confidence in mathematical ability that will be valuable throughout a college career. Placement: All Math 100 students are required to attend Math 193. Co-requisite: Math 021/022 or Math 100. Class meets on Tuesdays and Thursdays in room C108 from 3:20 PM to 4:10 PM.

II. Course Materials: Math 193 Booklet & Handouts. The booklet is available at UNM Valencia Book Store.

III. Attendance Policy: Students are expected to attend regularly and to be on time. Two unexcused absences in the first 2 weeks or three total unexcused absences are considered excessive and the student may be dropped from the class at the discretion of the instructor. If you are dropped from Math 193, you will be dropped from Math 100 as well. The student must be on time and remain for the entire class session, have the necessary course materials on hand and participate in class to receive full credit for attendance and participation each day. If absent, the student must see the instructor in person, contact her by email or leave a message within 24 hours to change an unexcused absence to an excused absence. Math 193 work will be completed in class most of the time, and each absence will reduce the attendance and participation grade.
