## PSYCHOLOGY 105 Syllabus - Dual Credit Spring 2019

**Course Description**: The course provides an overview of human cognitive processes such as attention, perception, memory, language, categorization, decision making, reasoning, and problem solving. Includes methods, theories, and applications.

In conjunction with the high school AP Psychology course, students will receive an overview of the major components of psychology. Topics to be covered include learning, cognition, perception, motivation, biological systems, social and abnormal psychology, development, personality and approaches to psychotherapy.

Learning Outcomes: Upon completion of the course students should be able to:

- Describe research findings in the major areas of human cognition.
- Differentiate the research methods used to study the various topics in cognitive psychology.
- Apply theories of cognition to the results of laboratory research.
- Apply the research on cognitive psychology to topics in the real world.

Textbook: David G. Myers, Myers' Psychology for AP, Second Edition

**Instruction**: The majority of the instruction will come from the high school AP Psychology course. I will conduct 4 lectures at the high school. Assignments will be posted on UNM Learn. Late work will only be allowed with a valid documented reason.

**Grading:** The final semester grade will reflect 50% from the high school grade and 50% from the online component. The online grade will be based on the following required assignments.

- 2 Article Response Assignments......25 pts each
- 4 Quizzes......50 pts each
- 1 Theorist Paper .....10 pts
- Midterm Exam.....100 pts
- Final Exam.....100 pts

There are 520 possible points. Grades will be based on the following percentage with the appropriate plus or minus sign.

100-90% = A (520-468 pts)

89 - 80% = B (467-416 pts) 79 - 70% = C (415-364 pts) 69 - 60% = D (363-312 pts)F = Below 312 pts
