<u>COURSE DESCRIPTION</u>: Critical Thinking for Math (2 credits) will help students develop and implement strategies for successful achievement in mathematics throughout their college career and beyond. Placement: Math 193 is required of all students who place into Math 100. **Co-requisite: Math 100.**
