CEO report

To My Colleagues,

I hope you had a relaxing and refreshing break. I spent the week in Santa Fe at the Legislature, working on our Senate Bill 163 to get permission for us to build a Workforce Training Center in Los Lunas.

Our bill passed unanimously late Friday afternoon. I want to express my appreciation for all our legislators who helped move this bill through, especially Senator Clemente Sanchez who sponsored the bill, and Representative Alonzo Baldonado who co-sponsored it. Several of our Advisory Board members and many of our community members from our county commission, our mayors, our chambers of commerce, the Isleta Pueblo, UNM, SBDC, and the Executive Director of the New Mexico Association of Community Colleges, our state association.

I will keep you updated as we await the Governor's signature of this

bill. In other legislative news, you might remember that we, along with four other Branch Colleges, were inadvertently left out of last year's Election Bill, moving local elections to November. I was able to speak briefly on this issue to the Rules Committee, and fortunately, the bill passed and is awaiting the Governor's signature.

Thanks to so many of you who helped with our Route 66 Gala in March. Congratulations to our Development Board and Marcus Gallegos, Cindy Shue, Sandy Sacher and the many volunteers from all over our campus who volunteered for this event. Our latest estimates are that the event earned over \$60,000 for endowment funds whose proceeds will fund student scholarships.

More good news for student scholarships is an anonymous endowment of \$25,000 whose proceeds will assist students with day to day financial issues that could affect their academic performance. In addition, the Daniels Fund has awarded our campus \$15,000 over a two-year period to pay for tuition for GED recipients, non-traditionally aged students, and former foster care youth.

Facebook has awarded the campus \$13,299 to host a series of short-term summer camps on: coding, internet topics including drones, cybersecurity, and solar technology.

Finally, our Student Government President, Hannah Dille, has been awarded a silver Coca-Cola Academic Team scholarship of \$1,250. She will be recognized at the Phi Theta Kappa Annual Convention in Orlando, Florida.

In addition, the Senate decided not to force UNM to reinstate the four sports teams that were cut last year in order to receive its state funding, instead opting to allow UNM to run its own affairs and to work towards compliance with Federal Title IX requirements regarding gender equality. The House-approved version of the budget would have required UNM to break those Federal Title IX requirements in order to receive funding from Santa Fe.

I will ask you to remember that elections for 2019-2020 Faculty Executive Committee members will occur during our final Faculty Assembly meeting of this academic year on 17 April. Don't be shy; your colleagues need you! Chairs, please consider nominating junior members of your divisions. If you're curious about what the responsibilities might include, feel free to ask me or any other member of the current FFC.

Finally, on a self-deprecating and less serious note: I visited my parents in Alabama over Spring Break. While driving with my dear old Mom, we saw this sign in front of a country church and I had to stop

National Library Week: April 7-13, 2019



Thanks to the Next Generation grant, I will be attending the week-long International Writing Center Association Summer Institute in June in Baltimore, working with writing center administrators from many places as we share ideas about how to make our centers powerful catalysts for writers' growth. I am thrilled that the theme of the Institute is "Cultivating Community." The announcement of this theme includes this statement: "We seek to build a community of practitioners by bringing together new and more experienced writing center professionals looking for strategies, renewal, and reinvigoration."

The announcement goes on to say, "Through workshops and discussions on a wider range of tutoring education and methods, community and campus outreach, social justice actions, and new approaches to research and assessment, we will, together, interrogate the ways we build community explicitly and implicitly as we also share and examine strategies for writing center administration." I am excited about this opportunity to deepen my practice and my connections, and I plan to bring back ideas and plans for consultant professional development and for best practices in our center.





There are ample opportunities to learn what others are doing to support college readiness using EdReady. The bootcamp model is

popular, though North Carolina demonstrated how they are offering different levels of support for underprepared students with a co-requisite model that has been very successful. The last workshop of the conference we spent time with the implementation team to discuss what would be most useful for them to focus on next. Contextualizing curriculum to careers and improved reporting made it to the top of the list.
