## Course Goals:

Learn the fundamentals of 3D modeling for games. Students will learn how to model, sculpt, and texture models, and how to add them to modern game engines like Unreal Engine.

## Learning Objectives:

By the end of the course, students will:

- (1) Have a solid foundation of the tools and techniques of 3D modeling
- (2) Texture 3D models with a variety of styles
- (3) Develop shaders to represent physical properties of objects
- (4) Use sculpting, particles, procedural generation, and other techniques to add detail and nuance to 3D assets
- (5) Be able to build assets and scenes for modern game engines

## Course Outline:

This course will alternate between projects and a more traditional structure. Half of the weeks will teach techniques and skills, with students following along and sharing their work. The other half are projects, where students use the skills they learned to fulfill goals like a set of low-poly assets or a realistic donut. All work will be shared using the UNM Learn discussion forum for peer discussion and review.

## Materials:

You **must** have:

- Internet Access, for UNM Learn, Zoom, and Youtube.
- Blender version 2.8 or above (<https://www.blender.org/>)
- Unreal Engine version 4.24 or above (<https://www.unrealengine.com/en-US/>)
- Notebook

All required software is free for this course, but internet access is critical to watch videos, get assignments, share work, and peer review.

### **Assignments:**

Assignments will be posted on UNM Learn (<https://learn.unm.edu>). Most assignments will have a deadline one week after it's assigned. Larger assignments will be broken up into smaller pieces (such as drafts or rough versions) each with their own due dates . You can use the calendar tool in Learn to track assignments and their due dates.

### **Late Work / Absences:**
