Introduction to Literature

Course Description:

Students will be exposed to a variety of literary genres that include fiction, poetry, and drama. Students will identify common literary conventions in each genre, understanding how specific elements influence meaning and are related to understanding cultural, historical, and sociological formations. Students will be expected to read, re-read, reflect and engage in literary analysis.

Student Learning Objectives:

After successful completion of the course, students will be able to:

- Read literature at the college level by gaining the ability to effectively identify and explain literary conventions, themes and tropes.
- Demonstrate a basic understanding of and ability to apply literary analysis (reader response, feminist, historical, cultural, and critical theory) when reading any text (novels, poems, plays, news articles, comics, memes, films, commercials, etc.).
- Apply critical thinking and analytical skills to understand the meanings in literature as well as developing an increased self-awareness of one's own life stories and the texts s/he encounters every day.

Essential Questions Asked Throughout the Course:

- How do we understand or learn about our Self better by reading?
- How do we learn to analyze or reflect on the world around us by reading?
- What is the power of storytelling and why does it matter?
- How do we create and understand stories by using literary conventions?
- How to we read and create literature to develop our own, unique voice?

Weekly Assignments

*Assignments are available every Monday and Due the Following Monday by Midnight Reading Logs: Students are expected to keep structured notes on each of the readings throughout the semester (template will be provided:

<u>Discussion Board</u>: responses to instructor prompts and fellow students' posts.

<u>Journal</u>: a writing response (guided with specific questions) about the weekly readings/texts. <u>Quiz</u>: multiple choice and T/F questions to test knowledge of key vocabulary, theoretical concepts, and points discussed in lecture and reading materials.

Midterm Exam 20% of Grade

The format will be a short answer essay questions that build upon the application of literary analyses learned in the first eight weeks. Students will be able to refer to Journal Entries and notes.

Creative Project 20% of Grade
