Course Information

Course Description

This course covers foundational concepts for professional development, including selected professional attributes and care competencies. The concepts covered are ethics, collaboration, leadership, and advocacy.

Course Objectives

Upon successful completion of this course, students will be able to demonstrated their understanding of the following core knowledge:

- 1. Ethics and the theoretical foundations, principles that guide professional nursing practice, and ethical foundations and systems for guiding decision making globally.
- 2. Collaboration in nursing in healthcare, the core competencies for interprofessional collaboration and the role of interorganizational collaboration in the delivery of quality patient care.
- 3. Leadership and the role of leadership in the delivery of quality patient care, able to identify delegation opportunities and hospital and professional leadership opportunities.
- 4. Advocacy and the importance of concepts of advocacy, legal implications, self-advocacy, and incorporating the chain of command and organizational policy to affect advocacy.

Course Competencies

At the completion of this course, the student will:

- 1. Examine the ethical values, virtues, principles, and policies that guide the moral delivery of health care.
- 2. Relate the nurse's interpretation of patient needs, concerns, and health problems with nursing decisions.
- 3. Discuss the factors which motivate individuals, groups, and organizations to deliver quality nursing care.
- 4. Determine how interactions of health care team members provide quality patient care.

Clinical Objectives

- 1. Able to identify and discuss situations in clinical that can be delegated.
- 2. Able to identify and discuss an ethical situation either in the clinical setting.
- 3. Able to identify and discuss a time that they/the nurse advocated for a patient in the clinical setting.
- 4. Able to identify and discuss multiple forms of collaboration in the clinical setting.
- 5. Able to identify and discuss leadership situations by the nurse/student in the clinical or work setting.
- 6. The student will be able to apply the concepts to a clinical or work setting.

CLASSWORK and Participation

Instructor Expectations:

As instructors we will give each of you 100% of our commitment to help you successfully complete the class. Respectfully, all the instructors expect 100% of your commitment to this class, including clinical. This includes attending all classes, reading the textbook /assigned articles, using the resources available to you. The class format will be taught using a variety of methods of instruction including: chapter readings, assigned readings of articles chosen by instructor, lecture, case studies, instructor assignments, and Evolve I-Human case studies. Attending class is expected as well as arriving to class on time. Both are definitely in the student's best interest. It is important that students ask questions in class so clarification of content can be discussed. Meeting after class with the instructor is also encouraged to answer any questions or clear up any issues.

Participation and Course Expectations:

Attending class is highly recommended. In the event, that class is missed, you must inform the instructor immediately. It is so easy to get behind and difficult to catch up. Numerous absences could result in class failure. Class is not a place to surf the internet, text friends or take naps. General class and small group discussions will be used in the class for participation as well as "pop quizzes." There is no make-up for any quiz or exam missed without previous discussion with the instructor with extenuating circumstances. There is the expectation that students communicate with one another in small group projects or discussions. There is the expectation that students keep and stay informed of course announcements. There is the expectation that students communicate with everyone in the classroom, the lab, clinical, the entire nursing program, and campus, in a civil and respectful manner and tone.

The students are expected to keep the instructor informed of class related problems, or problems that may prevent the student from full participation (send an email when you encounter problems so that the instructor knows you still have intentions of completing the course). A student success plan will be required for any problems that require mediation for resolution.

The UNM VC Nursing requires that students earn a course grade of ≥77% to pass all courses.

Exams are proctored, computerized, secure assessments (tests) comprised of questions utilizing a variety of formats (i.e. multiple choice, select all that apply, fill in the blank, short answer. Review of exams can be done individually the week after the exam is taken. Those students who receive a grade less than 77% MUST remediate with the instructor or success coach within 2 weeks of the exam. There will be no review of previous exams for the Final Exam. The Final Exam is cumulative.

Assignments:

There will be four I-Human case studies assigned. These must be completed by the assigned deadline. Failure to meet the deadline will result in a grade of zero for the case study. They will not be reloaded after the due date has passed.

For every concept, there will be a quiz. This will be completed in class at the start of the class. These quizzes will be random and there are no make-ups for missed exams or quizzes unless previously arranged by the student (due to extenuating circumstances, as determined by the instructor).

Kaplan: You are expected to maintain your Kaplan account. Every course incorporates a 4-part Kaplan testing process. See Handbook for additional information regarding Kaplan grading process. You will take a focused test, remediate that section, take a proctored (integrated test, and remediate that section.) The purpose is to begin to expose you to the style of questions to expect on the NCLEX. Kaplan testing and remediation is 20% of the course grade.

Kaplan I-Human: Every course incorporates 4 I-Human cases. Together they will make up 10% of your grade. For level one, you are required to achieve >55% as the grade given by Kaplan to earn the points.
