## **Course Description**

This beginning course examines the involvement of families and communities from diverse cultural and linguistic backgrounds in early childhood programs. Ways to establish collaborative relationships with families in early childhood settings is discussed. Families' goals and desires for their children will be supported through **culturally responsive** strategies.

<u>Credit-hour statement</u>: This is a three credit-hour course. Traditionally and on a college campus, class would meet for three 50-minute sessions/two 75-minute sessions of direct instruction for fifteen weeks during the Fall 2024 semester. Dual Credit students meet the required attendance required by your HS policies. College classes plan for a *minimum* of six hours of out-of-class work (or homework, study, assignment completion, and class preparation) each week. As a Dual Credit Student, out-of-class work will be up to your HS Instructor.

## **Course Competencies**
