Course Outcomes

Upon completion of this course, students will be able to:

- a. Explain how the scientific method and psychological research methodologies are used to study lifespan development.
- b. Recall key terms, concepts, and theories in the areas of neuroscience, learning, memory, cognition, intelligence, motivation and emotion, personality, health, disorders and therapies, and social psychology which better inform lifespan development.
- c. Explain how information provided in this course can be applied to life in the real world.
- d. Identify the major theoretical schools of thought that exist in developmental psychology as they relate to the self, culture, and society.

Practical outcomes (or praxis):

1. A *critical understanding* of psychology from history through sociality.
2. The ability to *create* psychological *material*.
3. To *teach* psychological *tools* to one another.
4. A *functional perspective* of psychology's use in our lives.
5. To *develop* psychological *relationships* with each other.
