COURSE DESCRIPTION

Art Practices I is the first of two required interdisciplinary art studio courses that explore the processes, ideas, and diverse media of visual arts at the foundational level. This course addresses the thematic concepts that are central to the nature of art making today. This first semester's assignments will investigate issues of Light, Frame, and Mark. A slide lecture, an assigned reading, and a short response paper will accompany each project. Visual problem solving will be emphasized throughout the course, in addition to an in-depth exploration of various materials and the nature of artistic meaning. The course will culminate in each student creating a final portfolio of the artworks they created during the course.

Course Objectives

By completing this course students will be able to:

- 1. demonstrate how frame, light, and mark can be used to communicate ideas in visual art.
- 2. produce two-dimensional, three-dimensional, and time-based art works.
- 3. develop a research practice that informs the development of art works.
- 4. critically analyze works of art.

5. assemble a final portfolio of artworks created during the course.

Teaching and Learning Strategies

This is an online class delivered via Canvas, UNM's online learning platform.

Video lectures, demonstrations, slide shows, assignments, and exercises, reading discussion forums, critiques, and regular one-on-one discussions with the instructor will be used as the learning tools in this class.

Additionally, there will be four critiques held as synchronous web-conferences via Zoom on the due date of assignments depending on student availability.

CLASS REQUIREMENTS

Attendance

This course is being taught online, meaning that all content will be offered online via Canvas. Students are expected to complete and participate in all course materials turning their work in using Canvas. Students are expected to attend four critiques when assignments are due either synchronously if available or by written critique format. The format is TBD but the expectation is that students are present and participate in all four critiques.

Studio Assignments

Studio Assignments are the art projects you will work on throughout the course. Each module will have a different theme and set of Learning Objectives and consist of Studio Assignments (including a Written Statement), Sketchbook Assignments, Critiques, Work-in-Progress Critique Discussions, and Reading Discussions. Class critiques for each assignment will occur on the date that the assignment is due. Please check the schedule regularly for these dates as they are a required part of your grade for each assignment. Stay tuned for critique format information.

Written Work and Discussion Posts

On the due date for each studio project, a two-page written statement is also due, which should address the outcome of your project, how successful you feel the piece is and what you could have done differently to make it even better. You should also make a connection between your own work and the ideas presented in at least one of the assigned readings. For detailed guidelines on writing a successful statement please refer to the document "Statement Guidelines" found posted in Module 1 on Canvas. **To write a successful statement, you should follow these guidelines.**

A Reading Discussion Post will be due for each module. These will be counted as part of your overall grade and must be completed on time. Please refer to the Discussion Board for instructions and refer to the schedule for the due dates.

Tracking Course Activity

Canvas automatically records all students' activities including: your first and last access to the course, the pages you have accessed, the number of discussion messages you have read and sent, web conferencing, discussion text, and posted discussion topics. This data can be accessed by the instructor to evaluate class participation and to identify students having difficulty.

All studio assignments will be graded using this rubric:

Grading and Lateness

- Assignments will be graded within 7 days of submission. There is a 2-day grace-period on all assignments (including Reading Discussion posts) meaning that as long as they are turned in within two days after the original due date, they will not receive a grade reduction. Assignments turned in within seven days of the original due date but after the 2-day grace period will receive a full letter grade (10 points) reduction to their assignment grade. No late work will be accepted after 7 days of original due date and will not be graded unless direct communication with instructor is initiated by the student.
