Yo Intro Criminal Justice People! I am excited to teach this class that covers a little bit of everything in our criminal justice system. It is also not a neutral topic! I expect that people will have a point of view about what they are studying and writing about, and that's fine. It would be strange if you did not! Also, online class is different, as you probably already know! I want to point out is that there is a schedule with deadlines, just as there is with face-face classes. The other kicker is that summer school goes fast! If you miss assignments, you will fall behind, and you cannot catch up. If you don't have time to devote to the class, consider taking it in the regular semester, as summer school is essentially "double time." I also know that "life happens," especially in our Covid world. If something has thrown you off, and you need an extra day to turn in an assignment, let me know.

I am happy to meet with you virtually to talk about the class, or just talk (!) during scheduled office hours, or by appointment. I am a sociologist by training, and I have taught criminal justice classes on a regular basis since 2015. It's always fun and interesting to interact with students about the course material.

My goal is to grade your work within several days so that you get feedback on a regular basis. I may sometimes fall short of this goal, but it is important to me so I will try my best. Generally, I don't email about grades but am happy to talk about them, whether virtually or over the phone.

Catalog Description

CJUS 1110: Introduction to Criminal Justice. (3) This course provides an overall exploration of the historical development and structure of the United States criminal justice system, with emphasis on how the varied components of the justice system intertwine to protect and preserve individual rights. The course covers critical analysis of criminal justice processes and the ethical, legal, and political factors affecting the exercise of discretion by criminal justice professionals.

Required Textbook:

Course Objectives/Learning Outcomes:

- 1. Identify the current practices and functions of the criminal justice system.
- 2. Understand and communicate how crime data is collected and measured and how this data informs the claims of policy makers and public policy outcomes.
- 3. Demonstrate the ability to compare and contrast the institutional practices and stratification of the U.S. criminal justice system with other criminal justice systems in the developed regions of the world.
- 4. Communicate an understanding of sociological theories of the U.S. criminal justice system through academic research and written assignments.
- 5. Describe the functions of the social institutions connected to crime, e.g., polity, media, education, family.

COURSE REQUIREMENTS

1. Weekly papers:

Everyone completes **seven out of eight of the weekly papers**, each of which should be two pages, typed double-spaced. You decide which paper to skip. Each of the weekly papers is worth 20 points. I will post the questions for the papers on Canvas. The weekly papers are generally due Sunday by 11 p.m. but be aware that there are several weeks that they are due on Fridays instead—you will see the due dates for each week. Please note that these papers are super important for the basis of your learning as there are no tests.

2. Response/discussion:

Everyone completes **five out of six short responses**, and you decide which week to skip. Each weekly response (approximately one page, typed double-spaced, which is about 250 words) is worth 10 points. I will post them on Canvas. They are due Wednesday by 11 p.m. Everyone in the class has been put into one of two groups for discussion. HOWEVER! While everyone must post their response to the material, i.e., videos and/or readings, they do NOT have to respond to others in their group—that's up to you. The idea is that you may find what the perspectives of others' interesting and wish to respond rather than feeling coerced to participate. I am grading these responses pass/fail.

3. Reflection papers:

You will write two reflection papers over the course of the semester. Each paper is four-five pages, typed double-spaced. The first is due Sunday July 3 by 11 p.m. The second is due Sunday July 31 by 11 p.m. Each paper is worth 45 points. I will post the assignment on Canvas. The assignment asks you to reflect on and apply various aspects of the course to your own life.

4. Policing and corrections papers:

Each person completes either the policing paper OR the corrections paper—you choose based on your interest and your schedule! These papers are worth 20 points each.

- a. Policing paper: Read the assigned chapters in *Tangled Up in Blue* and *The Black and The Blue* and write a short paper about your thoughts about policing in the U.S. today, referencing the chapters and our text. This is a two-page paper, typed double-spaced, due July 8 by 11 p.m. I will post the assignment on Canvas.
- b. Corrections paper: Read the assigned chapters in *Redemption Songs* and write a short paper about your thoughts about corrections in the U.S. today, referencing the chapters and our text. This is a two-page paper, typed double-spaced, due July 22 by 11 p.m. I will post the assignment on Canvas.

5. Formatting:

All writing assignments must be typewritten, double-spaced in a 12 pt. Times New Roman font. Also, papers must be submitted in either .doc or .pdf. Google Docs are not compatible.
