Course Description:

Students will be exposed to a variety of literary genres that include fiction, poetry, and drama. Students will identify common literary conventions in each genre, understanding how specific elements influence meaning and are related to understanding cultural, historical, and sociological formations. Students will be expected to read, re-read, reflect and engage in literary analysis.

Student Learning Objectives:

After successful completion of the course, students will be able to:

- Read literature at the college level by gaining the ability to effectively identify and explain literary conventions, themes and tropes.
- Demonstrate a basic understanding of and ability to apply literary analysis (reader response, feminist, historical, cultural, and critical theory) when reading any text (novels, poems, plays, news articles, comics, memes, films, commercials, etc.).
- Apply critical thinking and analytical skills to understand the meanings in literature as well as developing an increased self-awareness of one's own life stories and the texts s/he encounters every day.

Essential Questions Asked Throughout the Course:

- How do we understand or learn about or better understand ourselves through literature?
- How do we learn to analyze or reflect on the world around us by reading?
- What is the power of storytelling and why does it matter?
- How do we create and understand stories by using and identifying literary conventions?
- How can we read and create literature to develop our own, unique voice?

Course Participation and Graded Requirements

Course Expectations

- Together, we will create a learning environment based on clear communication, mutual understanding and respect.

EACH WEEK students will be *expected* to complete the following:

- View course module that may include lecture, video, and/or PowerPoint slides.
- Read the assigned readings (short stories, essays, poetry, etc.).
- Complete weekly Assignments: Journal, Discussions, Reading Logs and/or Quizzes.
- Expect to put in approximately 6-8 hours of study time per week.

Course Format:

New Material will post Each Monday, and be Due the following Monday by Midnight.

Weekly Assignments

40% of Grade

Reading Logs: Students are expected to keep structured notes on each of the readings throughout the semester (template will be provided).

Discussion Board: responses to instructor prompts and fellow students' posts.

Journal: a writing response (guided with specific questions) about the weekly readings/texts.

Quiz: multiple choice and T/F questions to test knowledge of key vocabulary, theoretical concepts, and points discussed in lecture and reading materials.

Midterm Reflection

20% of Grade

The format will be a short answer essay questions that build upon the application of literary analyses learned in the first four weeks. Students will be able to refer to Journal Entries and class notes while completing the exam. Students will have a week to complete the Exam.

Creative Project

20% of Grade

Creating original Media/Art/Visual Representation of Literary Analysis

Final Reflection

20% of Grade

The format will include a scene analysis of a play as well as short answer essay questions that demonstrate reflection upon literature analyses and storytelling techniques. Students may refer to all course readings, journal entries and notes to complete the assignment.

Student Accountability

Late Assignments Policy: Late assignments will NOT be accepted unless the student receives prior approval from the instructor. This means you must contact me before the due date. In case of extenuating circumstances, please contact me as soon as possible. Students will have one week to submit late work, after which time points will be deducted. Communication is key so please let me know your situation so I can best support you.
